- Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below on or before May 21, 2024 at 10:00am. Late bids shall not be accepted.
- All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
